

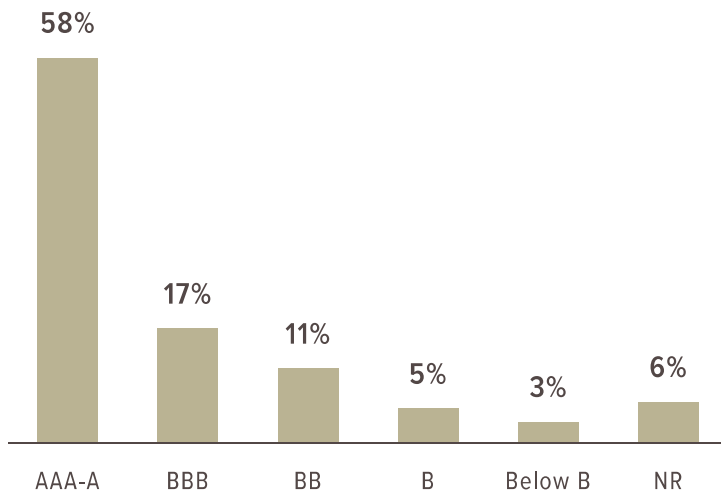
The Approach

Credit Quality



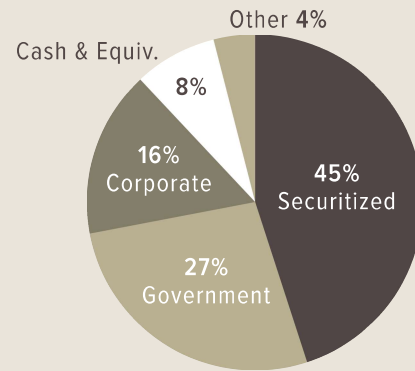
